I UNDERSTAND THAT THE PURPOSE OF SIGNING THIS DOCUMENT IS TO EXEMPT AND RELEASE CORAL REEF PARK CO. INC. AND ITS OWNERS, EMPLOYEES, AGENTS, AND ASSOCIATED PERSONNEL, THEIR BOATS WHETHER OWNED, OPERATED, LEASED OR CHARTERED) AND THE STATE OF FLORIDA DEP, HEREINAFTER REFERRED TO AS "RELATED PARTIES," AND TO HOLD THESE ENTITIES HARMLESS FROM ANY AND ALL LIABILITIES ARISING AS A CONSEQUENCE OF THE FOLLOWING, OR ANY OTHER ACTS OR OMISSIONS ON THEIR PART, INCLUDING BUT NOT LIMITED TO NEGLIGENCE OF ANY TYPE.

I UNDERSTAND THAT THERE ARE INHERENT RISKS INVOLVED WITH SNORKELING AND BOATING, including but not limited to equipment failure, perils of the sea, harm caused by marine creatures (including bites), acts of fellow participants, entering and exiting the water, boarding or disembarking boats, and activities on the docks and I HEREBY ASSUME SUCH RISKS.

I UNDERSTAND THAT I HAVE A DUTY TO EXERCISE REASONABLE CARE FOR MY OWN SAFETY AND I AGREE TO DO SO.

I assert that I am physically fit to snorkel and ride on a boat and I will not hold the Released Parties responsible if I am injured as a result of ANY problems (medical, accidental, or otherwise) which occur while snorkeling, riding on the boat, or otherwise participating in the trip.

I will not remove my floatation device at any time while in the water. I acknowledge that doing so will constitute a violation of safety rules and procedures for which I expressly assume the risk.

If I become distressed at the surface, I will immediately inflate my floatation device for floatation assistance.

I fully understand that the involved boat has limited medical facilities and that in the event of illness or injury appropriate medical care may be summoned by radio and treatment will be delayed until I can be transported to a proper medical facility. I agree in advance to these conditions.

I understand that any minors under the age of fifteen are not permitted to be in the water alone and agree that any minor will be accompanied by any parent or legal guardian at all times when in the water.

The participating dive store and/or boat have made no representation to me implied or otherwise that they or their crew can or will perform safe rescues or render first aid. In the event I show signs of distress or call for aid I would like assistance and will not hold the Released Parties, their crew, dive boats or passengers responsible for their actions in attempting the performance or rescue or first aid.

BY SIGNING THIS DOCUMENT IT IS MY INTENTION TO GIVE UP MY RIGHT TO SUE ANY AND ALL PERSONS OR ENTITIES REFERRED TO HEREIN WHETHER SPECIFICALLY NAMED OR NOT, AND IT IS ALSO MY INTENTION TO EXEMPT AND RELEASE ALL RELEASED PARTIES AND TO HOLD THESE ENTITIES HARMLESS FROM ANY AND ALL LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE AND I ASSUME ALL RISK IN CONNECTION WITH SNORKELING AND BOATING ACTIVITIES, INCLUDING BUT NOT LIMITED TO THE MAINTENANCE OF THE EQUIPMENT OR ORGANIZATION OF THIS ACTIVITY.

I have carefully read this contract in its entirety, fully understand its contents, and agree to the terms and conditions of this contract on behalf of myself, my heirs, and my personal representatives. This document constitutes the final and entire agreement between Released Parties and the undersigned. There are NO WARRANTIES expressed or implied, which extend beyond the description of the activity listed on this form. THIS IS A COMPLETE RELEASE OF LIABILITY AND A LEGALLY BINDING CONTRACT.

I have read this agreement, am aware that this is a release of liability and a contract between myself and the Released Parties. I sign it on my own free will and agree to be bound by it, from the date of my signature, forever into the future. UNDERSTOOD AND AGREED.

Snorkel Boat: Encounter, Sea Garden, Journey, Dolphin, Snorkel Express

Offshore snorkeling requires some essential skills, abilities, and stamina to safely participate in this activity. We would like you to review our list of essential skills and abilities and compare them with your own health and physical conditioning to ensure this activity is right for you today. This information is provided to you so you can make an accurate and informed decision before beginning this activity.

- 1. Must have the ability to follow written, verbal, and/or visual instructions independently or with the assistance of a companion.
- 2. Must be physically fit enough to swim up to 200 yards and/or tread water for up to 20 minutes.
- 3. Must have the ability to operate the snorkeling equipment including additional gear independently or with the assistance of a companion.
- 4. Must have the ability to wear a properly fitted personal flotation device as well as a properly fitted snorkel vest.
- 5. Must have the ability to enter and exit the Snorkel Boat independently or with the assistance of a companion, due to tidal variation the vessel will be a step up or down 12 inches.
- 6. Must have the ability to enter and exit the Unisex Marine Restrooms independently or with the assistance of a companion.
- 7. Must have the ability to enter and exit the water independently or with the assistance of a companion from the Swim Ladders (45 inch distance) by jumping/sliding into the water or utilizing one of the two 6 step swim ladders.
- 8. Participant with gear must not exceed the manufacturer's limit for the Swim Ladders weight limit: 350 lbs
- 9. Must have the ability to maneuver or propel oneself through water independently or with the assistance of a companion.
- 10. Must have the ability to tolerate 68-84 degrees Fahrenheit water for 90 minutes.
- 11. Must have the ability to withstand exposure to the outdoors, including bright sunlight, for a period of three (3) hours.
- 12. In the event of an "Emergency at Sea" must have:
 - a. The ability to right oneself and remain face up in the water with the aid of a personal flotation device.
